


A Letter from Dan and Dave

Born into a family of renowned philanthropists, Bobbi was immersed in a culture of giving from an early age. Her philanthropic journey is deeply rooted in her personal experiences with her mother, Catherine Filene Shouse. Catherine's legacy as the founder of Wolf Trap National Park for the Performing Arts in Virginia was one of the many inspirations for Bobbi's commitment to philanthropy and the arts.




A VISIT WITH BOBBI TOLLEY

When Bobbi decided to allocate her charitable donations to the Moorings Park Foundation, it paved the way for an expansion of the arts program benefitting all Moorings Park residents. As she fondly reflected on the creation of the Bobbi Tolley Art Studio on the original campus, her interactions with key figures played a pivotal role in its establishment. Among these figures was Toni Wilson, a former Art Instructor at Moorings Park, and fellow resident and artist, Adrienne Cozette. Bobbi credited Toni's keen eye for talent and dedication to nurturing artistic expression led to the hiring of Kim Willis, the current Art Instructor, ensuring the continued success of the program. She also credited Adrienne for igniting her motivation to become more deeply involved in supporting artistic endeavors at Moorings Park. "Adrienne is a fantastic artist," Bobbi warmly remarked,

acknowledging the profound impact of Adrienne's talent and how the program enriches lives to this day.



When asked about why having a dedicated space was important to Bobbi, her response was unequivocal: "Art is important, it's an escape, it's relaxing, it's spiritual and



it creates happy times. Everybody should have the ability to go there if they want to." Today, more than 140 residents participate in a variety of classes each month.

Among the programs funded by the Foundation, Bobbi is particularly drawn to OMA (Opening Minds through

Art), an award-winning, evidence-based, intergenerational art-making program for people living with dementia. "OMA has been a great gift," she remarks. "Kim's been a gift, she's done an awful lot to help improve the well-being of residents." By providing a dedicated space and the funding necessary to run the program, Bobbi's generosity provides residents with a sense of connection and a place to build relationships while expressing themselves through art.

Other contributions from Bobbi include the creation of the WWII Memorial Plaza, featuring General Eisenhower, in memory of her late husband, Brigadier General Benton C. Tolley, Jr., who began as an Air Force Navigator and U.S. Army Air Corps second lieutenant.



Bobbi's philanthropic giving is driven by a desire to make a tangible difference in the lives touched by the Foundation's mission. "I hope once I'm gone, it continues," she said, emphasizing her long-term commitment to the cause.

We sincerely thank Bobbi for her dedication to the Foundation which is a true testament to her belief in the transformative power of the arts.

Creating Opportunities: Forging Impactful Pathways

In a heartwarming display of support and collaboration, Moorings Park Foundation and Habitat for Humanity of Collier County have joined forces to make homeownership dreams a reality for Moorings Park partners. This new initiative operates on one simple yet powerful premise: when a Moorings Park partner is approved

for homeownership and meets the requirements through Habitat for Humanity, Moorings Park Foundation provides \$10,000 towards their down payment and/or closing costs.

This financial assistance not only significantly alleviates the initial cost associated with purchasing a home, but it also serves as a tangible expression of our residents' commitment to the well-being of the partners.

Luxton Antoine, an original campus Environmental Services partner for the last five years, received this assistance in December 2023.

By focusing on empowering individuals through homeownership, Moorings Park Foundation contributes to the long-term development and economic stability of our community. In the end, it's not just about building homes; it's about building hope, dignity, and a sense of belonging for every individual.

Fostering Futures: Partner and Dependent Scholarships

The scholarship program has been an integral part of the Foundation's mission since its inception, having awarded over 1,400 scholarships to our partners and their family members. These scholarships not only provide opportunities locally but across the U.S.

The Foundation's Scholarship Committee is comprised of Moorings Park residents and local community leaders, who meticulously evaluate and score each application based on GPA, household income, and essay questions.

What began over 25 years ago, awarding \$46,000 to 30 recipients, has flourished into 51 awards totaling \$277,500 in 2023. This remarkable growth stands as a testament to the residents of Moorings Park, showcasing their generosity to transform lives by turning the dream of higher education into reality.

Breaking Barriers: Empowering Through ESL Classes

The Foundation Board of Directors undertook an admirable initiative in 2023, aiming to support partners by offering English as a Second Language (ESL) classes. Following extensive surveys conducted among partners and their managers, it became evident that there was substantial interest in ESL.

The program was taught by a qualified instructor from Hodges University, spans 12 weeks, and participants gather once a week for three hours on their respective campuses. To earn a completion certificate, they are required to achieve a minimum

score of 80%. The inaugural cohort, containing 30 partners, commenced their ESL journey during the week of September 25 at both the Moorings Park Grey Oaks and Grande Lake communities. This ESL program not only equips partners with language proficiency but also instills confidence, enabling them to communicate effectively with colleagues and residents. Moreover, it opens avenues for professional growth within Moorings Park, empowering partners to explore new opportunities.

Career Success: Attaining Goals Through Scholarships

Celeste Lynch, a Naples resident for 24 years, brings 38 years of experience in senior living. With a Master of Science in Gerontology from Florida Gulf Coast University, Celeste has dedicated her career to serving seniors, particularly those with neurocognitive disorders. Her journey at Moorings Park began in



2002, where she rose from Director of Recreational Therapy to Executive Director at Moorings Park Grey Oaks in 2021. Celeste takes every opportunity to acknowledge that her career's success is directly linked to the scholarships from the Foundation. She expresses gratitude for the opportunity to support the Foundation's efforts in benefiting partners and seniors.



Resident Support

Benevolent Care: Bringing Peace of Mind


Caring for our residents through benevolent care is a cornerstone of Moorings Park Foundation's mission. By offering this type of financial assistance, we ensure all residents have access to funding they may need to live comfortably and maintain their quality of life, regardless of their ability to pay. Recognizing unforeseen circumstances can arise, this foundational program promotes peace of mind.

Elevating Aging: Special Programs and Campus Life

Special programming is another way Moorings Park Foundation seeks to serve our residents and because of the generosity of John and Connie Rakoske, a Johns Hopkins Fellowship Program has been funded through January 2025. By leveraging the expertise of Johns Hopkins Medicine in gerontology, residents will benefit from evidence-based approaches to aging well and managing age-related health conditions. In addition to programming, the Foundation is an avenue to enhance Moorings Park Communities. Through a thoughtful process, additional amenities or renovations can be funded by residents.

In 2023, several donations were made by residents to make our campuses even more beautiful. Gene and Susan Frey, of Moorings Park Grande Lake, graciously supported the installation of a flagpole and seating area on that campus. Their generosity was celebrated with a flag-raising ceremony, a gesture that embodied patriotism, unity, and respect for the nation's flag.





After learning about the desire residents had for a croquet lawn and pickleball courts on campus, Bob Fisher decided he would help bring their wishes to life. As a former resident of the Ocean Reef Club in Key Largo, Bob was familiar with the popular sport and its unique charm. It was important to Bob that the additions to Lyon Park offer enjoyable

and engaging recreational activities to players of all ages and abilities. Because of his generosity, residents will enjoy these games for years to come.

Our Centers for Healthy Living (CHL) prioritize residents' well-being by offering physician-based services tailored to their needs, while creating an On the original campus, John and Connie Rakoske believe in fostering a vibrant community where residents can thrive physically, socially, and emotionally. Because of this belief, they saw the importance of supporting the renovation of the CHL Café to bring a redefined, full-service, beautifully decorated eatery and social space. Fondly named, C&J Café will stand as another extraordinary commitment John and Connie have made to the betterment of Moorings Park and the support of their fellow residents.

Whether it's renovating common areas, upgrading recreational facilities, or reinforcing the bonds that unite Americans, these gifts help the Foundation continue to uphold its mission to ensure that seniors can age with dignity, grace, and fulfillment.



Community Support: Improving the World Around Us

Moorings Park Foundation acknowledges the importance of its role as a leading advocate for services that enhance senior well-being. We realize that supporting local non-profits presents a tremendous opportunity for us to make a meaningful difference.

The Community and Educational Grants Program stands as a testament to our residents' generosity, serving as a gateway for them to extend their support. This program, led by a dedicated committee of residents, guarantees that the combined contributions of our donors make the greatest possible difference in the lives of those in need – be it the underprivileged, the homeless, individuals battling cancer, those living with Parkinson's, or those requiring essential end-of-life care services.



In July of 2023, the Foundation awarded \$640,500 to twenty-eight deserving local organizations. \$418,500 to community organizations that serve seniors, and \$220,000 to educational programs or scholarship funding that help support students studying healthcare or other areas that serve seniors and the community.

Grace Place - \$40,000

Leaders Empowered to Achieve Dreams Program - a college and career access program for 9-12 grade students at Golden Gate High School.

Guadalupe Center - \$35,000

Provides 10, \$4,000 Tutor Corps College Scholarships to underprivileged children in Immokalee.

Hodges University - \$25,000

Provides scholarships for students studying to become Clinical Mental Health Counselors, Dental Hygienist, and Physical Therapy Assistants.

Immokalee Foundation - \$15,000

Healthcare Summer Camp - provides funding for 35 students to get hands-on learning opportunities in the field of healthcare.

Immokalee Technical College - \$15,000

Student Emergency and Gap Program - grants that provide additional financial support and supplemental learning and/or living needs.

Lorenzo Walker Technical College - \$20,000

Provides scholarships for practical nursing, surgical technology, dental assistant, nursing assistant, and phlebotomy students.

New Horizons of SWFL - \$15,000

After-school education program to boost graduation rates for 150 underserved youth who are interested in occupational therapy, social work, and rehab counseling.

Project Explore - \$10,000

Workforce Readiness Program - a program for adults with disabilities that offers hands-on experience to explore potential career paths at the Moorings Park Communities.

2023/2024 Community Grants

Alzheimer's Association, Florida Gulf Coast Chapter - \$6,000

Collier County Health Fair Awareness Initiative to increase awareness of their services through attending health fairs.

Amber's Antibodies - \$5,000

Grant Program - provides direct financial assistance to help Collier County families deal with the financial burdens of a cancer diagnosis and to help fund research initiatives to seek a cure.

AVOW Hospice - \$20,000

Adult Grief and Bereavement Services - provides counseling for 1,400+ seniors annually.

Baker Senior Center - \$60,000

Brain Joggers Early Memory Loss Group supports the expansion of the group.

Beverly's Angels - \$35,000

This grant helps to eradicate homelessness among seniors by providing basic human needs like shelter, food, and clothing.

Cancer Alliance Network - \$25,000

Senior Financial Assistance - provides financial aid, support, education, and resources to senior cancer patients.

Collier Resource Center - \$25,000

Senior Outreach Plan - provides expansion of information, referrals, advocacy, and case management for Collier citizens.

Collier Senior Center Golden Gate - \$65,000

The grant provides mental health counseling through the UPSLIDE Program and direct financial assistance to low-income seniors.

David Lawrence Mental Health Center - \$22,000

Provides behavioral healthcare treatment to uninsured or underinsured seniors.

Florida Lyons Eye Clinic - \$20,000

Helps to provide comprehensive eye care for seniors who cannot afford vision services.

Hunger & Homeless Coalition - \$60,000

Seniors of Firm Footing Program - helps to alleviate homelessness and loneliness.

Immokalee Fair Housing Alliance - \$25,000

Funding to develop housing that is safe, healthy, and affordable for low-income seniors of Immokalee.

Lighthouse of Collier - \$12,500

Funds a program to teach visually impaired seniors how to live safely and independently at home.

Naples Take a Solider Fishing - \$5,000

Grant provides a weekend of appreciation for local senior Veterans.

Parkinson's Association of SW Florida - \$8,000

Speech Therapy Program - allows for program expansion to serve more seniors.

Valerie's House - \$10,000

Grandparents Raising Grandchildren Program provides grief support for children and families who are grieving the loss of a loved one.

Warrior Homes of Collier - \$15,000 (Formally

known as Wounded Warriors of Collier County)
Senior Veteran Support Services - grant

Natalia's Story

At the age of 65, Natalia began a journey that would test her resilience after fleeing an unimaginable war leaving behind her husband who remained to fight. Natalia fled Ukraine with her two daughters and two granddaughters in hopes of a better life here in the States. Moving from her familiar life with friends and loved ones, Natalia spoke no English and found herself with nowhere to turn once she arrived here. While she was grateful to get out of her country alive, she had no idea what her next steps were to protect and support her family. Luckily, the Collier Resource Center, a Moorings Park Foundation Grant Recipient, whose mission is to empower the people of Collier County by providing information, referrals, advocacy, and case management, was able to find a home for Natalia and her family.

But the story doesn't end there. Another beneficiary, Beverly's Angels, known for collaborating with various non-profits, stepped up. Not only did they provide supplies for the kitchen, bedrooms, and bathrooms, but they also supplied clothing and food. This offered a sense of comfort and hope for Natalia and her family. Because of Beverly's Angels,



their house became a home by infusing it with warmth, comfort, and a sense of belonging.

During times of adversity, the non-profits that the Foundation supports through the Community Grants Program are leaving a profound mark on the local community. They are providing shelter to the homeless, nourishment to the hungry, and essential resources to empower others toward success, all the while embodying qualities of grace, love, and kindness.



Securing Tomorrow:

The Power of Legacy Gifts

Legacy gifts, also known as planned gifts, are crucial to Moorings Park Foundation because they ensure financial health, sustainability, and long-term success.

Because of three visionary individuals, nearly \$380,000 was received from legacy gifts in 2023. These gifts equated to approximately 30% of the Foundation's total charitable giving and ensures the donors philanthropic goals continue to be supported even after their lifetime. We deeply thank these donors for being innovative, creative, and proactive in their approach to solving problems and shaping the future.

Planned gifts provide stability that allows the Foundation to plan and execute our programs effectively without relying solely on annual donations. A planned gift also offers you many potential advantages: the opportunity to increase spendable income, the elimination or reduction of capital gain taxes and possibly federal and state estate tax savings. Most planned gifts stem from wills or living trusts, however, other blended gifts can include life insurance, retirement assets, real estate, and securities.





We extend our heartfelt gratitude to Joanne for her belief in this initiative and for joining a cause that will be cherished and enjoyed by generations to come.






